

Saints Constantine and Helen Capital Construction Campaign (CCC) Committee Meeting Church Office Thursday, March 2, 2017 (Rescheduled due to weather/travel conditions on February 23, 2017 Meeting)

Members present: Kosta Tsandes, Dawn Hatanelas, Anna Barker, Billie Zumo, Linda Panopoulos, Mary Messer and Julie Lehman.

- I. After prayer, meeting commenced @ 5:40pm
- II. Motion to approve Minutes of February 9, 2017 was made by Mary Messer and seconded by Anna Barker. Unanimously approved.

III. Old Business

- a. Treasurer's Report:
 - Dawn Hatanelas, Treasurer, reported that our current Bank Balance is \$63,220.08, as attached to these Minutes. Motioned by Linda Panopoulos and seconded by Billie Zumo and to accept the report. Unanimously accepted. Lehman reminded committee that this is actual "cash in the bank" and does not reflect future pledges. Mary stated that Jim Messer was applying for "rebates" from the electrical power company that would be recognized by the Committee once they are received.
- b. Marketing 500 Piece Puzzle--Fundraising Activity Lehman met with Sunday School Teachers to explain the purpose of the project. Consensus was to commence with this activity after the Fellowship Hall ceiling had been repaired. Each bag of "pieces" can be purchased for \$25.00 for the Sunday School children to put together. To date: \$100.00 has been collected.
- c. Update on Repair/Renovations: Mary Messer reported that the repairs on the Fellowship Hall ceiling have been pushed back to March 15th as the asbestos issues must be resolved prior to any construction efforts. It is anticipated that these repairs/renovations will be completed within a three-week time period.

- a. The Committee discussed the following fundraising activities during and after Pasha:
 - 1. Host Sunday Fellowship after Church services on April 2nd. No basket will be placed for donations.
 - 2. Consider undertaking the Church Name Day dinner on May 21, 2017, pending approval of Parish Council. If the Parish Council is doing this then CCC will undertake another fundraising activity on June 11th, Father's Day.
 - 3. Consensus was that CCC would participate in a "canned food for the needy" project at a later date.
 - 4. Greek Festival Baking (Koulourakia) is on March 13th & 14th at 9:00am. CCC members are encouraged to help with this project.
 - Pledging for future projects:
 Lehman reminded Committee that we <u>can accept</u> written pledges for future projects.

V. Other Concerns/Comments

- a. Lehman has submitted an ASF grant for this fiscal year, attached to these minutes
- b. Other future fundraising ideas were discussed such as, Rainbow Church logo plastic cups, a Wine and Cheese Tasting event, Bingo and a Movie night.
