## III. Treasurer's Report

Dawn Hatanelas, Treasurer, reported that our current Bank Balance is \$53,330.08 as attached to these Minutes. Motioned by Mary Messer and seconded by Anna Barker to accept the report. Unanimously approved.

### IV. Old Business

a. Name Day Celebration
